The undersigned is hereby notified and agrees that photography and photographic printing is not an exact science and that on occasion film, printers, photographic equipment, computer, cameras, photo booth equipment, software and memory cards and materials may be defective. The undersigned agrees specifically to waive any claim of negligence, breach of warranty or contract, mental harm or distress. In case of such defects and malfunctions Chris Gonzales Photography is limited to refund of payments.

Destruction of equipment and props by users of the photo booth is subject to a replacement fee; which covers the cost of replacing or repairing broken photo booth equipment or props.

Overtime rental fee begins 15 minutes after the end of the scheduled contract time at \$90 / hour. Idle time is when the booth is set up, and the rental has not started. This fee is \$90 per hour.
