You are invited submit an application for a space at the Days at the Dock Festival to be held April 28th – 9am-6pm & 29th from 10am until 4pm. Application requirements are listed below. The festival will be held under the bridge at Holden Beach

There will be a limited number of food vendors with minimal duplication of product. Registration fee is \$250 and spaces are 10' across and 10' deep. (Please include the tongue in length of trailers). Each additional foot will be \$10/ft. There will be no refunds after you are accepted. Electricity, water, and gray water disposal will be the only things included with your fee. **We will not provide grease barrels. You will need to take it with you. Any dumping of grease is a federal crime and will be treated as such.** No Generators will be allowed. You will need to bring your own food grade water hose; three-way hose connector and back flow preventer. **You will be responsible to contact the Brunswick County Health Department to obtain a Temporary Food Stand Permit. Please note NO FOOD PREPARATION IS ALLOWED UNTIL A PERMIT IS ISSUED BY THE HEALTH DEPARTMENT.**

- 2) A copy of your current General and Product Liability insurance policy with a minimum \$500,000 limit.
- 3) A check made payable to: GHBMA
- 4) A current photo of your booth or trailer if different from last year.

Set up will be Friday, April 27th starting a 12pm. You must be set up and ready for Health Department inspection by 3pm on Friday. All vehicles must be out of the festival area on Saturday morning by 8am. Vehicles will only be allowed back in when the police deem the area safe to do so.
